## HORSE AND MONTHLY PAYMENT:

Lessors shall provide to Lessee(s) a certain horse, known as" \_\_\_\_\_\_" (hereinafter "the horse"). In consideration t, Lessee(s) shall pay to Lessors, commencing, \_\_\_\_ Day of \_\_\_\_\_, 201\_\_, the sum of \$ 445 per month (full lease – one rider or \$335 each for a 50-50 share), payable on the fifteenth (15th) of each month preceding all months in which payment is due (e.g., February's payment due on January 15, etc.) If the horse shall die through no fault of Lessee(s), Lessors reserve the right, but assume no obligation; to substitute another horse of substantially similar value and kind in place of the horse listed hereinabove. If the horse shall die, and Lessors' rights to collect sums due for previous periods pursuant to the provisions hereof. There shall be no refunds made by Lessors under any circumstances. If the horse shall die, become lame, or otherwise be unusable as a saddle horse as intended, due to Lessee(s) negligence or misuse, then and in that event Lessee(s) stipulate that they shall pay to Lessors within seven (7) days of death or disability, the value of the aforesaid horse, which is agreed to be \$ 3,500.00

## **USE OF HORSE & SHARING:**

Lessee(s) agree to use the horse for normal recreational purposes, and for no other. The horse shall be well treated when in Lessee (s) care. Lessors reserve the right to use the horse when not being used by the Lessee (s), and the parties agree to cooperate in arranging a mutually agreeable riding schedule to the satisfaction of both parties. If the parties cannot reach agreement on a schedule, same shall be established by Lessors.

# **FARRIER:**

Lessee(s) agrees that all hoof trimming will be performed by or at the direction of Lessors and is the responsibility of the Lessors. Shoeing and any other related farrier service fees for said horse shall be paid by the Lessee(s), provided that the Lessors have previously approved of such work and the farrier to be used.

# VACCINATIONS:

Lessors will pay for all worming fees, tetanus, influenza, encephalomyelitis, and rhino vaccinations fees and any other normal routine veterinary care and shall be provided by the veterinarian chosen by Lessors.

#### **VETERINARIAN:**

Lessee(s) agree to be responsible for any} damage or injury to the horse while in the Lessee(s)' possession or control, including loss of use of the horse until it has recovered or been replaced. In the event the horse shall require the services of a veterinarian, Lessee(s) will immediately contact the Lessors. If the Lessors cannot be reached within a reasonable time frame, Lessee(s) is hereby authorized as agent for the owner to: (1) <u>Call Dr. Kuhn at DuWayne Aimal Clinic in W. Chicago, IL</u>, at telephone number 630-231-0404 and should he not be available, (2) ask for any other licensed veterinarian from their Office. All fees charged by the veterinarian shall be the sole and exclusive responsibility of the Lessee(s), with no liability whatsoever on the part of the owner for the service fee(s) when they arise out of and during lessee(s), possession or control of the said horse.

All other veterinarian service fees will be procured and paid by the Lessor except when the required service fee(s) arise(s) out of or while riding said horse by the Lessors, in which case Lessors shall pay for such veterinarian fees.

#### FEED:

Lessors agree to supply salt and/or trace minerals with hay or pasture as needed. Lessee(s) agree to supplement with grain, as specified or appropriate, at Lessee(s) expense, based upon the Lessors recommendation relative to the horse's weight and/or the amount of work and exercise being performed to keep in condition.

#### TACK:

Lessee(s) agree to provide their own saddle, bridle, blanket, brush, comb, etc., as necessary.

#### **TRAILERING:**

Lessee(s) agree not to remove the horse from the farm, at any time by trailer or by truck.

#### **FARM RULES:**

Lessee(s) agree to abide by all rules established by Lessors whether in writing or verbally. The facilities and the horse are to be well treated and maintained by Lessee(s). Rules attached.

#### TERM:

Except as amended in writing by agreement of both parties, this Lease Agreement will continue until May 31st of the calendar year following the year of this agreement. It will be renewed automatically on May 31<sup>st</sup>, unless written correspondence is received to the contrary, by Galusha Farm, prior to May 1st each year, from the Lessee.

#### **TERMINATION AND AMENDMENT:**

Failure of the Lessee(s) to make timely payments of any installment under the terms of the agreement, shall give the Lessors, in their sole discretion, the right to collect from Lessee(s) any sums due hereunder.

This Lease Agreement shall be terminable upon one (1) month's notice by the Lessor. The Lessee(s)' notice must be given no later than May 1st in order to be effective on the last day of May.

This Lease Agreement may be amended by written agreement of the parties at any time.

#### LIABILITY:

Lessee(s) agree to hold harmless the said owner as specified in the Liability Agreement.

#### ENTIRE AGREEMENT AND ASSIGNMENT:

This Lease Agreement, together with the Liability Release Agreement constitutes the entire agreement between Lessee(s) and Lessors. The Liability Agreement is attached hereto and by this reference made a part hereof. Lessee(s) shall not assign their rights hereunder.
